NON-MUNICIPAL WASTE HAULER LICENSE APPLICATION

City Ordinance #35.059 Annual Registration Period is July 1 through June 30

- 1. Complete the attached application, indemnification agreement and schedule of vehicles.
- 2. Certificates of insurance and insurance policies must be filed with the application.
 - *The contractor/subcontractor shall not commence work under this contract until they have obtained the insurance required within the contract. All insurance coverage shall be with issuance carriers acceptable to the City of Mount Clemens. If any insurance is written with a deductible or self-insured retention, the contractor/subcontractor shall be solely responsible for said deductible or self-insured retention. The purchase of insurance and the furnishing of a certificate of insurance shall not be a satisfaction of the contractor/subcontractor's indemnification of the City of Mount Clemens. The contractor/subcontractor is responsible to meet all MIOSHA requirements for on-the-job safety. The contractor/subcontractor and subcontractor shall procure and maintain during the life of this contract for the following coverage:
 - a) Workers Compensation Insurance in accordance with all applicable statutes of the State of Michigan. Coverage shall include Employers Liability Coverage.
 - b) Commercial General Liability Insurance on an "Occurrence" basis with limits of liability not less than \$1,000,000 (as stated above level of hazard) per occurrence and/or aggregate combined single limit, Personal Injury, Bodily Injury and Property Damage.
 - c) Motor Vehicle Liability Coverage including Michigan No-Fault Coverage with limits of liability not less than \$1,000,000 per occurrence combined single limit bodily injury and property damage for all vehicles used in the performance of the contract. The City reserves the right to require specific limits of coverage if the contract involves the use of a motor vehicle for other than transportation to work site(s). MCS 90 Endorsement on Vehicle Insurance; Statutory where applicable.
 - d) Additional Insured. Commercial General Liability Insurance as described above shall include an endorsement stating the following shall be an additional insured: "The City of Mount Clemens including all elected and appointed officials and employees and all other individuals working on behalf of the City are named as additional insured and said coverage shall be considered to be the primary coverage rather than any policies and insurance or self-insurance retention owned or maintained by the City of Mount Clemens."
 - e) Cancellation Notice. Workers Compensation Insurance, Commercial General Liability Insurance and Motor Vehicle Liability Insurance as described above shall include an endorsement stating that thirty (30) days advance written notice of cancellation, non-renewal, reduction and/or material change shall be sent to:
