GENERAL: Plumbing work shall not begin until the application for permit has been filed with and approved by the City of Mount Clemens Community Development Department. All installations shall be conformance with the State Plumbing Code. The City of Mount Clemens Water and Sewer Department will be in contact with you regarding the installation of the water meter after this permit has been issued.

EXPIRATION OF PERMIT: A permit is valid for an initial 6 months unless otherwise stated. To extend a permit contact the Community Development Department **BEFORE** the expiration date. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
