As summer ends, I want to thank the Downtown Development Authority (DDA) for the incredible concerts they coordinated! Also, a big thank you to the businesses who contributed to the concert series. The DDA is already beginning the planning phase for next year's events. If you have any suggestions, they

Over the past few months Mount Clemens has received two grants. These grants will enable the city to make much needed improvements to our Downtown. The first grant was from the Macomb County Placemaking Grant program. In addition to money from the DDA, this grant will enable more lighting on our Downtown streets. The second grant is from the Michigan Economic Development Corporation's RAP program. MEDC awarded Mount Clemens up to \$813,000 for our Cherry Street Mall revitalization project.

Coming up this quarter, I will present the State of the City address. Hosted by the Macomb County Chamber, the State of the City will take place on Friday, October 14th, 7:30 a.m. at Cairns Community Center located at 58 Orchard St, Mount Clemens, MI 48043. Winter Snow Removal & Snow Emergency Information

Please keep in mind the Street Department will be clearing all major streets first during a snow storm. We will plow the side streets as quickly as possible once the major streets are clear.

This winter during snowstorms, please park your vehicles at an off-street location. Parking in a driveway or parking lot will be greatly appreciated. Onstreet parking can resume after the city has plowed the streets.

Whenever there is an abundance of snow accumulated, or there is a possibility that snow will accumulate to extraordinary depths, the city may declare a "Snow Emergency". Local television and radio news stations will be alerted when a snow emergency has been declared and cancelled.

After the initial notice of a snow emergency has been declared, please remove all vehicles within six hours on any major streets and/or within twelve hours on local streets or alleys. Once the entire street has been cleared of snow from curb to curb and no additional snow has

accumulated or is predicted to accumulate, vehicles may then resume parking on that street.

Clerk's Corner

General Election is Tuesday, November 8, 2022

The next election in Mount Clemens is the general election on Tuesday, November 8, 2022.

Important Primary Election Deadlines

- Last day to register to vote by mail or online October 24, 2022.
- In-person voter registration at city clerk's office with proof of residency is October 25, 2022, through November 8, 2022 (Election Day).
- Public accuracy test of voting equipment at 9:00 a.m. at City Hall
- Last day to have an absent voter ballot mailed to a voter November 4, 2022.
- Last day to receive an absent voter ballot in person at the city clerk's office November 7, 2022, by 4:00 p.m.

Extended Hours for City Clerk's Office

The Mount Clemens City Clerk's Office will be open on Saturday, November 5, 2022, from 8:00 a.m. to 4:00 p.m. to assist voters with voter registration and absentee ballots.

Keep the Campaign Shirts and Buttons at Home on Election Day!

Michigan election law stipulates that "a person shall not post, display, or distribute in a polling place, in any hallway used by voters to enter or exit a polling place, or within 100 feet of an entrance to a building in which a polling place is located any material that directly or indirectly makes reference to an election, a candidate, or a ballot question" (MCL168.744). This prohibition includes campaign clothing, campaign buttons and campaign literature. Please abide by the law and do not enter any polling place with these items.

DO DEAD VOTERS STAY ON THE ROLLS?

Deceased voters' ballots are not counted in Michigan. If a person cast an absentee ballot and the clerk confirms they died before Election Day, that vote will be rejected and the person will be removed from the voter rolls. Those who claim otherwise are spreading harmful misinformation. Learn the facts at Michigan.gov/SOSFactCheck.

This change will be beneficial to the city's water customers, as well as reduce the volume and frequency of delinquent water bill payments. Monthly water billing implementation will begin early 2023. 
Winter Tax Bills

Residents will receive a winter tax bill on or around December 1, 2022, and it will be due on February 28, 2023. Every resident will receive a tax bill, even if your mortgage company pays them on your behalf. Please keep this copy for your records. Any balance remaining on 2022 taxes will be turned over to the Macomb County Treasurer's Office on March 1, 2023. All payments on or after that date will be payable to: Macomb County Treasurer, 1 S. Main St., Mount Clemens, MI 48043. Their phone number is 586-469-5190

* Please note: When writing a check, it must be the exact amount due or a partial payment. We cannot accept an overpayment on taxes.*

Where Do My Tax Dollars Go?

The Charts below reflect a Summer and Winter Tax Bill for an *owner-occupied home*¹, using the average 2022 *Toxable Volue*² and an average of the 2022 Millage Rates (which vary by school and Downtown Development Authority district). Summer tax bills are mailed out by July 1st, and Winter tax bills by December 1st. Different millages are paid on each bill. While the Treasurer's Office collects all of these, we only keep those dollars due to the city and distribute the rest to the various taxing authorities



³ Courses Decapied means eligible for the Principal Residence Exemption (PRE). Properties without PRE pay an additional 18 mills of school taxes.

³ Familie Value is the legal term reflecting the Assessed Value of a property, adjusted by provision of State Lau referred to as Proposal A, which limits yearly increases to <u>5% or rate of inflation</u> (whichever is less) during the duration of a person's ownership.

Redevelopment Ready Community Designation

The Michigan Economic Development Corporation (MEDC) Redevelopment Ready Communities program is offered to municipalities across the state. This is a voluntary certification program promoting effective redevelopment strategies through a set of best practices. The program measures and then certifies communities that integrate transparency, predictability and efficiency into their daily development practices. The certification is a formal recognition that a community has a vision for the future and the fundamental practices in place to get there. Certified communities encourage business attraction and retention, offer superior customer service, and have a streamlined development approval process making pertinent information readily available. Once certified, communities are able to utilize additional marketing tools through the MEDC to promote development and redevelopment.

At the city commission's August 15, 2022 meeting, the city was presented with a plaque signifying its designation as the state of Michigan's 6th community to reach Essentials status. Although not an exhaustive list, some of the items that have been completed include:

- The adoption of the 2016 master plan update.
- The creation of a public participation plan.
- The creation of an online development guide.
- The updating of the city's boards and committees handbook.
- Accepting credit cards for payment of fees and permits.
- The creation of a training strategy for its development related boards.
- The creation of an economic development tab on the city website.
- The adoption of a capital improvement plan as part of its FY23 budget.
- The adoption of a new user-friendly zoning ordinance in 2021 which replaced a 2003 zoning ordinance.

I would like to thank all of the staff and local leaders, as well as our counterparts at the MEDC, for supporting this effort. With the Essentials designation, the city has now unlocked ongoing benefits, including continued technical assistance, marketing assistance and more.
